## RULES

- 1 All entrants must be USBC certified and a member of the Local Youth Association (MTCUSBC) and must abide by all rules and regulations of USBC which will govern the tournament.
- 2 DRESS CODE – All entrants must come neatly dressed in a center issued shirt, the USBC Youth jersey or a lapelled collared shirt, dress slacks, neat jeans or knee length shorts/skirts. No profanity on clothing, no hats can be worn. No cell phones, headphones, iPods or electronic gadgets in the settee or on the lanes permitted.
- 3 Format –Three games shall be bowled in each event. Teams will consist of three bowlers. The doubles event will be immediately followed by the singles event. All events score shall be calculated from the first 3 scores bowled in the team, doubles & singles events.
- 4 Handicap for this tournament shall be 90% of 200. Trophies awarded shall be at least 1 in 6.
- 5 Averages – (re-rate rule 319 does not apply) tournament average shall be
  - a. Highest current average in a certified MTCUSBC league based on at least 12 games as of 1/1/2024
  - b. If entrant does not have a current average or 12 games, 2022-2023 MTCUSBC highest league average on at least 12 games shall be used.
  - c. Anyone without an average listed may enter with a 200 average.
  - d. Tournament director reserves the right to assign averages or re-rate bowlers based on other information available
- 6 Divisions: There will be 5 handicap divisions based on averages:  
 NOTE: tournament director reserves the right to cancel/merge any divisions in any event
